## Mobile Food Preparation Vehicle Operating Permit Application

All Mobil Food Preparations Vehicles operated within the Town of Victor shall be registered with the Town of Victor Planning and Building Department. Each unit operated shall be in compliance with the Fire Code of New York State Section 319. To verify compliance, the applicant shall provide 3<sup>rd</sup> party inspection from an accepted agency as listed below.

This registration only confirms compliance with the Fire Code of New York State. It does not give any specific or implied permission to operate on any private, municipal, or state road. It further does not give any specific or implied permission to operate within any park or on private property. The applicant shall be responsible for obtaining proper permission to set up and operate.

In addition to the Town of Victor Operating Permit, all federal, state, and local laws pertaining to operating a business and pedaling apply. The Town of Victor Operating Permit is only valid in the Town of Victor. For operation within the Village of Victor, please contact the Village of Victor at 60 East Main St. Victor, NY 14564. The permit is valid for 1 year from the date of issue.
