

NOTICE OF PUBLIC HEARING

PLEASE TAKE NOTICE THAT ON THE 16TH DAY OF JULY, 2025, AT FIRE STATION NO. 2, LOCATED AT 380 HIGH STREET, VICTOR, NY 14564, THE BOARD OF FIRE COMMISSIONERS OF THE FISHERS FIRE DISTRICT WILL HOLD A PUBLIC HEARING, WHICH SHALL COMMENCE AT 7:00 PM, TO CONSIDER THE FOLLOWING RESOLUTION: THE BOARD OF FIRE COMMISSIONERS OF THE FISHERS FIRE DISTRICT PROPOSES TO DISSOLVE THE FISHERS FIRE DISTRICT AND THE TOWN OF VICTOR ASSUME RESPONSIBILITY FOR FIRE PROTECTION SERVICES FOR RESIDENTS WITHIN THE FISHERS FIRE DISTRICT BOUNDARIES. THE PROPOSED DISSOLUTION SHALL BECOME EFFECTIVE ON AUGUST 31, 2025. AFTER THE CONCLUSION OF THE PUBLIC HEARING, THE DISTRICT BOARD MAY MEET IMMEDIATELY FOLLOWING THE PUBLIC HEARING TO VOTE ON THE DISSOLUTION.

DESCRIPTIVE SUMMARY

THE BOARD OF FIRE COMMISSIONERS OF THE FISHERS FIRE DISTRICT PROPOSES TO DISSOLVE THE FISHERS FIRE DISTRICT AND THAT THE TOWN OF VICTOR ARRANGE FOR FIRE PROTECTION SERVICES FOR RESIDENTS OF THE DISTRICT. ALL ASSETS AND PROPERTY OF THE FIRE DISTRICT SHALL BE TRANSFERRED TO THE TOWN OF VICTOR. THE PROPOSED DISSOLUTION SHALL BECOME EFFECTIVE ON AUGUST 31, 2025.


Proposed Plan for the Dissolution of the Fishers Fire District

The Board of Fire Commissioners for the Fishers Fire District hereby proposes, pursuant to General Municipal Law, Section 774, the following as its dissolution plan for the dissolution of the Fishers Fire District:

- A. The name of the local government entity to be dissolved is the Fishers Fire District (the “District”);
- B. The District is a Fire District, as that term is described in New York State Town Law, General Municipal Law, and other New York State authorities. The boundaries of the District are described in **Schedule B** hereto;
- C. Upon dissolution, the Town of Victor, in its discretion, will arrange for fire protection services for residents of the District;
- D. The fiscal estimate of the cost of dissolution is less than \$25,000.00, being primarily legal fees;
- E. There will be no public employees of the District to be transferred upon dissolution, as all employment relationships will be terminated at the time the dissolution becomes effective;
- F. The District holds certain assets, the major assets being as follows, all of which will be transferred to the Town. Below is not an exhaustive list of assets:
 - 1. Real property, including two firehouses, two parcels improved by buildings and one vacant lot with an approximate value of \$ 6,038,700;
 - 2. Fire apparatus and equipment valued at approximately \$963,000;
 - 3. Fund balances (approximate) as follows, as of April 30, 2025
 - (a) Engine Reserve Fund: \$ 1,696,761;
 - (b) Building Reserve Fund: \$561,675;
 - (c) Tax Stabilization Reserve Fund: \$ 561,277;
- G. The fair value of all the District’s combined assets, including the items listed above, is approximately \$10,563,650.20.
- H. The District currently holds LOSAP funds in trust in the amount of \$457,762.81 (as of April 30, 2025). Upon dissolution, these funds will be distributed as required by law so as to protect those funds for the intended beneficiaries.

- I. The District has no indebtedness, bonded and/or otherwise, but is reserving for certain possible OPEB liabilities in the amount of \$400,000;
- J. There are no agreements entered into by the District which will exist, be required, or which would need to be disposed of as of the date of dissolution;
- K. The manner and means by which the residents of the District will continue to be furnished municipal services following the District's dissolution will be determined by the Town of Victor;
- L. There are no terms for the disposition of the District's assets and the disposition of its liabilities and indebtedness, other than the District will settle all liabilities during the winding up of its affairs and all remaining assets will be transferred to the Town of Victor;
- M. No local laws, ordinances, rules or regulations of the District shall remain in effect after the effective date of the dissolution;
- N. The effective date of the proposed dissolution of the District is August 31, 2025;
- O. The public hearing on the dissolution of the Fishers Fire District shall be held on 16th day of July, 2025, at Fire Station No. 2 at 380 High Street, Victor, NY 14564, and shall commence at 7:00 p.m.;
- P. There are no other matters desirable or necessary to carry out the dissolution of the Fishers Fire District.


