<input type="checkbox"/> Fence	A survey map, showing location of the fence relative to the property lines and buildings on the property; any areas of the property locations of easements on the property; information on the style and height of the fence.
<input type="checkbox"/> Fireplace	Specification of the type of fireplace or solid-fuel appliance (fireplace, solid fuel, insert, decorative logs, etc.); location of the unit in the building; brochure of unit being installed, showing UL or ASTM approval and manufacturer's specifications for setbacks and use; provisions for combustion air, if required; chimney details, showing compliance with specific unit to be installed
<input type="checkbox"/> Fire alarm	Installation or modification of a commercial fire alarm system. Scope of work document showing compliance with NFPA 72.
<input type="checkbox"/> Fire suppression system	Installation or modification of a fire suppression system. Scope of work documents showing compliance with NFPA 13.
<input type="checkbox"/> Furnace/ HVAC/ Geothermal	Scope of work document or contract, indicating the type of unit being installed, its efficiency rating, and any duct work installation. If geothermal system, include survey map showing location of lines relative to structures and property lines.
<input type="checkbox"/> Generator	Specifications about the unit being installed including make, model number, and overall dimensions. A general plot plan showing the location of the unit(s) and distances from the house, windows, doors, and gas meter or fuel tanks.
<input type="checkbox"/> Water heater/ Pool heater	Scope of work document or contract, indicating the type and location of unit.
<input type="checkbox"/> Roofing	Scope of work document or contract indicating current roof, if roof-over (#of layers presently) or re-roof, if ice/water shield will be installed, and any other work to be completed.
<input type="checkbox"/> Septic System	Results of percolation tests witnessed by the Town Engineer's Office and a site plan showing the design and cross-section of the wastewater disposal system, the relation to lot lines, adjacent and on-set well or water supply, and buildings.
<input type="checkbox"/> Sanitary Sewer Connection / Septic Removal	Scope of work document, receipt from Farmington Sewer, overall sewer lateral layout with cleanouts, method for septic system demolition including in-fill
<input type="checkbox"/> Solar Panel	Specifications of the panels to be installed and related electrical diagrams, including any structural requirements for roof mounted panels or general plot plan showing location if ground-mounted.
<input type="checkbox"/> Windows	Specifications on the windows to be installed, including U-values, and indicate the size of windows to be installed and the rooms they are serving.
<input type="checkbox"/> Other	When directed by Planning & Building staff, include a full scope of work of the proposed installation of the system and documents to show the work will comply with the NYS Building Codes
